#### 2022/124 Approval of Minutes

#### 2022/125 Clerks Report

## 1. Defibrillator Training

The Community First Responder for Cleobury Mortimer has agreed to give some training. The 11<sup>th</sup> May was suggested. Once arranged it will be advertised on the Notice boards and social media.

2. The clerk sourced "20" stickers to put onto waste bins, but it was agreed not to purchase them.

#### 2022/126 Parish Matters

- 1. There has been a request for a salt bin on Bosals Bank on the way to the Ford. A suitable site needs to be found before the Parish Council requests and purchases a bin.
- 2. The damaged salt bin is still outside the Church. The clerk to report again.
- 3. The salt bin outside Rhydfelen, SY8 3QU needs refilling
- **4.** Ask Andrew Clayton if he can clear-out the layby on Halls Bank.
- **5.** There is no entrance to the footpath by Hints Farm and the sign needs replacing.

## 2022/127 A4117 Road Safety Improvement Scheme

The road safety improvement scheme proposes the following elements:

- Speed limit:
  - Reducing the existing National Speed Limit to 50mph starting at the "Craven Place" junction to the entrance of Doddington;
- · Road markings:
  - Refresh sections of worn carriageway markings (include speed roundels):
  - Introduction of "dragons teeth" markings when entering the 40mph zone at Doddington;
- Road Signs:
  - Installation of a Vehicle Activated Sign (VAS);
  - Damaged posts to be removed;
  - New attention signs on yellow-backed boards displaying sheep and horses;
  - New "repeater" signs to be installed throughout the extent of the 50mph speed limit to encourage compliance.

The Councillors agreed to make the following comments:

- 1. The Councillors want confirmation that the road studs would be replaced at the same time as there have been many problems over the years with them.
- 2. The warning signs should be Cattle not Horses.
- 3. The Councillors want confirmation of what activates the "Sheep VAS"? Is it just when a 50MPH is reached?

# 2022/128 King Coronation 6<sup>th</sup> May

The Clerk has contacted Tom Harris and provisionally booked him for 6<sup>th</sup> May. The Village Hall Committee have now arranged a fund-raising event in June with Tom Harris for the entertainment. The members of the Parish Council agreed That they would not go ahead with the event on the 6<sup>th</sup> May as this free event may jeopardise the fund-raising event. It was agreed to purchase a biscuit tin for each household instead and not hold an event.
