1. Defibrillator Training

2. Ownership of the Common in the Parish

The clerk contacted the Commoners Association about the ownership of the Common. The common on the bottom side of the road from Doddington to Cornbrook is owned by 3 sisters, from Cornbrook to Clee Hill the bottom side of the road, belongs to a syndicate of 12 people. The top side of the road from Clee Hill to Doddington is believed to belong to Hanson's Quarries but that has not been confirmed.

3. Road Width Warning Signs

A few signs were discussed but it was thought that the red triangle sign with the width stated inside would be the most appropriate. There are 3 possible signs down to Hints with posts that could be attached to but the clerk to liaise with SC.

4. Bin stickers

The clerk showed some bins stickers with "30" on that may be useful to put on

the bins across "Hints" to try and help slow traffic down. The clerk was asked to see if there are "20" stickers available.
