In a recent communication re the sale of a SSHA property at Hints Meadow Coreley, Connexus who manages the properties said their customers have told them that their priority is to have homes that are safe and secure, with affordable heating that is easy to use and can be controlled so the heating and hot water is there when needed. They assess all the older properties when they become empty to see if they can reasonably be brought up to this

standard. In this case, unfortunately it is not possible, due to the age of the property and sloping site with limited parking and poor access to the rear garden. The property is perfectly safe and will create a great home for someone with the means to carry out improvements and for whom the cost of heating is not an issue, but it does not meet the long term requirements of the Housing Association.
