Update report from Friends of Coreley – Telephone Box – Oct

Since the last update in September the works to the exterior of the ex-BT phone box have been concluded following the procurement of the gold paint for the crowns.

Operations undertaken in the period:

29/09/21 First cost enamel to crowns on the 3 visible elevations

06/10/21 Second coat enamel to crowns on the 3 visible elevations

This leaves the jubilee Library sign to be refixed.

A strategy for the internal works will be set out. The complications are that it is practical only for one person to work in the box at anyone time (this is despite the record for 12 adults and 2 children achieved in Edinburgh in August 2003). Also the door will need to be wedged open partially during any operations involving removal of flaking paint etc, the weather will again play a part although not to the same extent as the exterior.
