- 1. Whilst Mr B Austin was distributing the Parish Plan review information a number of residents from Cornbrook and surrounding areas referred to Clee Hill Quarry and the conditions that had been attached to the various planning Permissions they have been granted. The open meeting went ahead, although only 22 people attended, a number of issues were raised. 4 parish councillors attended along with Unitary Councillor Simon Harris and two officers from the Safer Neighbourhood team. The Committee would like to thank everyone that attended. Areas identified which will be covered in the questionnaires are: Communication: areas of the Parish not feeling part of the parish. It was suggested that a "Welcome Pack" for every newcomer would be a good idea, and their contact details given, so over a period of time a portfolio can be built. This can then be used to circulate information more widely and timely to more people.
