**Tenbury Transport Trust:** Carole Palethorpe came to talk about the Trust. They have 3 mini buses and the Teme Hopper, Caroline has been employed to do the research work. It is written into the 106 Agreement with the new Tesco in Tenbury that funding be given towards transport. An integral part of the plan will be to make contact with all villages and related organisation's in the Tenbury & Teme catchment area, in order to establish the need for improved community transport whether by minibus or car. The office can tell you how much a journey will cost. If there are enough numbers a regular services could be operated. There is a good relationship between the other service providers in the community so could work together with them. Also a number of questionnaires will be at Coreley Fete this coming Saturday. Caravan Site: Mr and Mrs Thompson came to talk about their new Caravan Club Certificated location site. The field officer from the Caravan Club came out to access the site and thought it was suitable.
